PARTECIPAZIONE AL GRUPPO DI LAVORO FNOMCeO

Il Presidente Dott. Giorgio Mortara informa che la FNOMCeO (Federazione Nazionale Ordine dei Medici Chirurghi e Odontoiatri) ha invitato l'AME a partecipare alla stesura di un testo su inizio della vita e a partecipare al convegno "Etica e Deontologia di inizio vita" che si terrà a Ferrara il 24 ottobre 2008. E' una grande occasione per l'AME di aderire ad un evento che parte da un'organizzazione medica nazionale, che ha dimostrato un grande interesse per la nostra associazione al punto di spostare il convegno, che inizialmente era fissato per sabato 25, permettendoci quindi di partecipare rispettando lo Shabbat. Gianfranco Di Segni e Guido Coen, in rappresentanza dell'AME, hanno partecipato il 19/06/2008 ad un incontro con il Gruppo di Lavoro FNOMCeO (Federazione Nazionale Ordine Medici Chirurghi e Odontoiatri) sulla Bioetica, preliminare al convegno di Ferrara "Etica e deontologia di inizio vita". Al documento stilato dal Dott. Panti sono state proposte alcune modifiche, sentito il parere della nostra Commissione Bioetica per renderlo accettabile anche dal punto di vista dell'etica ebraica. Ci si ripromette, in occasione del Convegno di Ferrara (se ci verrà dato spazio) di esplicitare i singoli punti. Appena disponibile vi faremo avere il testo finale.

Lavoro in corso per FNOMCeO sul tema "Etica e Deontologia di inizio vita". Proseguono gli incontri in vista del convegno che si terrà a Ferrara il prossimo 24 ottobre

Si è tenuto il 19 giugno scorso, presso la FNOMCeO, il primo incontro tra la Commissione per la Bioetica della FNOMCeO e i rappresentanti di Associazioni e Società Scientifiche di riferimento in vista del Convegno che si terrà il 24 ottobre 2008, promosso dalla FNOMCeO in collaborazione con l'Ordine dei Medici Chirurghi e degli Odontoiatri di Ferrara, su "Etica e Deontologia di inizio vita".

Si è trattato di un momento di confronto volto a verificare se l'attuale assetto del Codice di Deontologia Medica sia in grado di far fronte alle diverse sensibilità e ai diversi valori morali che emergono nel momento in cui ci si trova dinanzi a tali tematiche.

"Il dibattito sui delicati temi bioetici coinvolge, infatti, le diverse componenti culturali, religiose e civili della nostra società e in tal senso - come ha dichiarato il Presidente Bianco - a noi medici, responsabili dei nostri ruoli e delle nostre funzioni, non potrà che risultare proficuo uno scambio di opinioni, convinti della necessità di mantenere sempre aperto il dialogo sui principi che regolano la professione medica".

Tra gli argomenti sul tavolo dei lavori la sessualità responsabile sotto il profilo della prevenzione e della contraccezione: la procreazione medicalmente assistita; la procreazione cosciente e responsabile, tutela della maternità, interruzione volontaria della gravidanza; l'assistenza ai neonati in età gestazionale estremamente bassa.

IMA – WF BYLAWS: VERSIONE DEFINITIVA?

Questa è l'ultima versione, dopo le nostre molteplici osservazioni ed interazioni con i colleghi israeliani. Lo sottoponiamo alla vostra attenzione per avere un parere di cui servirci nella discussione dello statuto medesimo in occasione del Convegno IMA a Tel Aviv il prossimo Aprile.



IMA-WF Bylaws

I. Name of the Association

1. The name of the association shall be IMA World Fellowship (hereinafter, “the IMA-WF”)

II. Validity and Authority:

2. The IMA-WF is an organ of the Israeli Medical Association (IMA) and draws its authority from IMA regulations.

3. Any regulation or decision of the IMA-WF that does not reconcile with or conform to or that contradicts IMA regulations or decisions is inherently invalid.

III. Objectives and Range of Activity:

4. The objectives of the IMA-WF are to create and enhance mutual bonds between Israeli health professionals (including physicians, residents, fellows, medical students and allied health professionals) and their counterparts in other countries and to give individual members and chapters an opportunity to identify with and contribute to Israel, the IMA and the progress of medicine in Israel.

5. The IMA-WF will welcome members at the IMA offices in Israel. The IMA will host guests, make presentations and assist in arranging joint meetings with other organizations/individuals, whenever possible.

6. The IMA-WF will assist in arranging visits at medical institutions and organizing presentations by physicians, leaders in the medical field and IMA officials.

7. The IMA-WF will define projects, from time to time, for which chapters are encouraged to raise funds, including, but not limited to, grants for physicians from various chapters to come to Israel or for Israeli physicians to go abroad, in order to participate in fellowship programs.

8. The IMA-WF will assist in exchange programs or fellowships by directing participating physicians to the Health Ministry for a temporary license, and providing assistance in finding a position in a medical institution and lodging.

9. The IMA-WF will assist members wishing to make connections with Israeli physicians in various fields and medical institutions, for social or professional purposes, and will serve as a channel for professional ties between doctors as well as a central base between all members/chapters around the globe.

10. The IMA-WF will serve as a source of solidarity and a clearinghouse of support for Jewish communities in need, including, but not limited to, the initiation and/or coordination of humanitarian missions, in collaboration with other organizations.

11. The IMA-WF will provide members with information about IMA and WF activities, as well as answers to frequently asked questions, via the newsletter, "IMA Around the Globe" and the IMA website.

12. The IMA-WF will alert members to attacks on Israel and/or Israeli medicine in the medical press, and will provide assistance in combating anti-Israel sentiment and advocating for Israel and Israeli medicine, as well as encourage pride and solidarity with Israel.

13. The IMA-WF will provide members with information about upcoming conferences in Israel, and offer discounts to conferences where the IMA is part of the organizing committee as well as to conferences of the different IMA societies. The IMA-WF will, with the assistance of its member chapters, make efforts to arrange for CME credits for international conferences in Israel.

14. The IMA-WF will assist in the coordination of joint research projects with Israeli medical experts.

15. The IMA-WF will facilitate the participation of members in programs, missions and courses in Israel, initiated by volunteer and other organizations, in collaboration with the IMA.

16. The IMA-WF will help facilitate networking opportunities, information exchange and other opportunities for collaboration among individual members and chapters.

IV. Membership

17. Membership in the IMA-WF may be on an individual basis or through membership in one of the IMA-WF chapters or affiliate organizations.

18. Medical doctors with a valid medical license in their country of practice, medical students, and members of allied medical professions (including, but not limited to, dentists, osteopaths, chiropractors, podiatrists, nurses, psychologists, physiotherapists, occupational therapists) and biomedical scientists in healthcare or academia are eligible to submit an application to join as members of the IMA-WF. Members are entitled to all benefits of membership, including the right to vote and to be elected to institutions of the IMA-WF. Rights exclusive to physicians, to be determined from time to time by the executive board, shall be limited to physician members.

V-Acceptance procedures

19. A physician or allied health professional, as stated above, who wishes to be accepted as a member of the IMA-WF shall submit an application to the Central Board. A member may decide to apply as an individual member or as part of a chapter. In the latter case, the application shall be forwarded through the chapter.

The Board shall decide to accept or reject the application, and shall determine the type of membership. The decision shall be forwarded to the applicant in writing.

If the Board rejects an application, it shall explain its decision in writing and give the applicant an opportunity to appeal the decision to the Executive Committee.

Notwithstanding the above, any member who applies through a IMA-WF chapter shall be automatically accepted for membership in the IMA-WF.

VI-Rights and obligations

20. Each member is entitled to participate in IMA-WF conferences, including the World Assembly. The right to vote and be elected to institutions of the IMA-WF shall be as provided in sections 18-20. Each member must abide by decisions accepted by institutions of the IMA-WF.

VII- Membership fees

21. All members shall be required to pay annual membership fees, to be determined by their individual chapters and approved by the Executive Committee from time to time. Chapter members shall submit fees to their local branch, 10% of which shall be allocated to the IMA-WF, as determined by the Executive Committee from time to time. Members not belonging to any chapter shall submit their fees directly to the IMA WF, in an amount corresponding to the 10% of the fees charged for chapter members in that country.

VIII-Cessation of membership

22. Membership in the IMA-WF shall terminate upon one of the following events:

- a. Death of the member
- b. Written notice by the member of termination of membership. In the case of an individual member, such notice shall be sent to the Israeli office of the IMA-WF. In the case of a chapter member, such notice shall be sent to the chapter, which shall notify the Israeli office. Termination of membership will take effect upon receipt of the notice by the Israeli office or by the chapter, as the case may be.
- c. Termination of the member's professional license.
- d. In the case of a chapter member, termination by the chapter of such individual's membership. In such a case, the member may submit an application directly to the Israeli office of the IMA-WF for consideration.

IX-IMA-WF chapters

23. IMA-WF chapters represent the local organ of the IMA-WF, and their function is to promote the policy and decisions of the IMA-WF institutions and to encourage local scientific, social and cultural activity. In addition, the chapters shall handle matters related to their members that are not addressed by other bodies within the IMA-WF and which are of a local nature.

24. The IMA-WF shall allow a group of members in any country to form a sub-chapter affiliated to the country chapter or an independent organization. However, there shall be only one officially recognized chapter per country.

25. Any existing organization of physicians may join as an affiliated organization to the IMA-WF. However, members of such organization may not be elected to executive positions within the IMA.

26. The IMA and the IMA-WF shall serve as a central base among all chapters.

X- Association Institutions World Assembly

27. The World Assembly shall convene once every four years, on a date and at a location to be determined by the executive committee, provided that the Assembly shall take place in Israel. Invitations shall be sent to all members at least six months before the date set. In addition, notices shall be sent to all members at least 60 days before the conference stating the agenda of the Assembly, or, alternatively, shall direct members to a location where the agenda is publicized.

28. All members are entitled to attend the Assembly, but only delegates shall have the right to vote at the Assembly. The delegates will be elected by their local chapters prior to the Assembly, and will be voted in as delegates at the Assembly.

29. The IMA WF Executive Committee shall be solely responsible for carrying out decisions of the World Assembly.

30. The functions of the World Assembly shall include

- a. election of officers
- b. conducting of scientific, business and social programs as proposed by the Executive Committee
- c. revision of bylaws
- d. approval of fundamental decisions taken between meetings of the World Assembly.
- e. other functions as shall be decided upon by the Executive Committee from time to time.

Chairman of the IMA-WF

31. The chairman of the IMA-WF shall be an Israeli, elected by the IMA at its national convention.

Executive Committee

32. The Executive Committee shall be composed of 27 members, as follows: the Chairman of the IMA-WF who will serve as chairman of the Executive Committee as well as president of the Central Board, plus 26 additional members, among them 13 Israelis, who shall be elected at the IMA national convention, and 13 non-Israelis, who shall represent the following regions, and shall be elected by delegates from the region which they represent:

- US-3 members
- Canada-1 member
- Latin America-1 member
- Europe-3 members
- Australia, New Zealand, South Africa-1 member
- FSU (Former Soviet Union) -1 member
- Smaller countries (by rotation)-3 members, one of who shall represent the European region and one from the Latin American region.

“Smaller countries” shall be defined as countries with a membership of less than 100.

33. The World Assembly can elect to change the proportions stated in paragraph 32 in the event that a certain region increases or decreases in membership size.

If the elected representative of the chapter is unable to come to the World Assembly the Board of the chapter is entitled to send a replacement.

34. The Executive Committee shall convene at least once a year in Israel, unless decided otherwise by the Chairman.

35. The Executive Committee shall be responsible for decisions taken between meetings of the World Assembly. In addition, they shall serve other functions within the IMA-WF, including, but not limited to:

a. Publicity of local and IMA newsletters.

b. Promoting the purposes and goals of the IMA-WF abroad and providing information about Israel, Israeli medicine and the IMA and WF.

c. Organization of programs for hosting foreign doctors in Israel in a variety of frameworks.

d. Organization of regional and international conventions of the IMA-WF.

e. Publicity for IMA-WF.

36. Each member of the Executive Committee may appoint a delegate who shall substitute for him in the event he is not able to be present at the World Assembly. Such substitute delegate shall be entitled to vote on behalf of the absent delegate. Such a delegate must be approved by the chairman of the country / region he represents.

Central Board

37. The Central Board shall be composed of 11 members of the Executive Committee. The Central Board shall consist of 6 Israelis, who shall be elected at the IMA National Convention, and 5 non-Israelis, who shall be elected by and from amongst the Executive Committee at the General Assembly. The president of the Board shall be the chairman of the IMA-WF and chairman of the Executive Committee. In addition, the secretary and treasurer shall be appointed from among the Israeli members.

38. The Central Board shall convene as needed, and shall administer all regular business of the IMA-WF by mail, fax, telephone and email between meetings.

All meetings with outside parties and all decisions made by members of the Central Board must be approved by the Chairman, who shall also receive a protocol of any such meetings or decisions.

Finance Committee

39. The Finance Committee shall consist of the IMA legal advisor or his representative, the IMA-WF treasurer and three additional members of the Executive Committee, to be elected by such Committee (two of whom shall be Israeli and one of whom shall be non-Israeli). The IMA legal advisor shall serve as chairman of the committee. The WF chair shall serve as an ex-officio member.

40. The Finance Committee shall prepare the IMA-WF budget for approval by the Executive Committee and shall handle any other issues pertaining to the IMA-WF budget, shall oversee

IMA-WF accounting and shall initiate new policies regarding financing of IMA-WF activities and grants.

In addition to the above, all expenses in the IMA-WF budget allocated to the IMA must be approved by the IMA Secretariat or any other body determined by them.

41. The Finance Committee shall convene yearly, or as needed, and shall submit an annual report to the Executive Committee.

Board of Controllers

42. The Executive Committee shall elect a Board of Controllers comprised of three members, at least two of whom shall be Israeli. The members shall themselves elect a chairman.

43. The Board of Controllers is autonomous and is bound only by the rules of ethics, law and IMA and IMA-WF regulations. The Board of Controllers shall be accountable to the World Assembly and its members shall not serve on any other IMA-WF institution.

44. The Board of Controllers is an auditing body that shall oversee activities of IMA-WF committees and institutions, the decision-making process and implementation of IMA-WF decisions.

45. The Board of Controllers shall submit an annual report to the Executive Committee and a report to the World Assembly every 4 years.

Rules of Procedure

46. Unless otherwise specified, the procedural rules specified in this section shall apply to all meetings of IMA-WF institutions.

47. Only members of the relevant institution shall participate in meetings unless the chair of the meeting decides otherwise. The chair of the meeting may invite other people, at his discretion, as observers for a particular session or as permanent observers.

48. Travel and hotel costs for all WF meetings shall be at the expense of the attendee or his representative chapter, unless specified otherwise.

49. Minutes shall be taken at each meeting. The minutes shall state the names of participants and a summary of the main points. Decisions shall be recorded in full. At the beginning of each meeting, the minutes of the previous meeting shall be confirmed.

50. If the regulations do not state otherwise, a member of an IMA-WF institution who is absent from four consecutive meetings without adequate reason, shall cease to serve in the institution and shall be considered as having resigned, provided that before his participation is terminated, he is given a fair opportunity to state his case to the institution. Action of this kind is to be initiated by the chair of the given institution.

51. Unless otherwise specified in the regulations, a legal quorum of members in each meeting shall be one third of the committee members. If there is no quorum at the appointed time, the

meeting shall be legal with any quorum one half hour after the time set for the beginning of the meeting.

52. The chair shall establish the order of speakers in a committee

53. Any member may raise a suggestion for a decision regarding topics on the agenda. Decisions shall be taken by simple majority and by a show of hands, unless otherwise stipulated in these regulations.

54. Votes shall be cast by secret ballot at the request of 10 percent of eligible voters present at a meeting or by decision of the chair of the meeting and/or if specified in these regulations.

55. An issue that was raised for discussion and defeated shall not be discussed again for six months from the last date on which the issue was raised. If a member feels that the circumstances have changed, he may ask the chair of the meeting to raise the issue again before the six months have elapsed. If the chair is persuaded that the member's request has merit he shall bring the issue to a revote.

56. Each member who has the right to vote has one vote. In the event of a tie, the chair of the meeting shall decide.

57. The use of the masculine gender in these regulations is for convenience purposes only. All regulations shall apply equally to males and females, unless specified otherwise.
